## Re: Ensure Access to Reliable Care & Services Provided By Pharmacists

Dear Majority Leader Thune, Speaker Johnson, Minority Leader Schumer, and Minority Leader Jeffries:

The undersigned organizations write to urge you to support the Ensuring Community Access to Pharmacists Services Act (ECAPS). This bipartisan legislation would enable patients to continue to receive timely and consistent care from pharmacists for essential health services and allow pharmacists to continue to provide testing, treatment, and vaccinations for common infectious diseases that harm our communities. By urgently acting to support and advance this legislation, Congress can ensure pharmacist services are covered, protecting rural and senior communities.

During the 2023-2024 respiratory season, pharmacists administered 74% of vaccinations in the United States. More recently, pharmacists have thus far administrated more than 64% of adult doses of influenza vaccines during the 2024-2025 flu season. These services prove to save lives and reduce costs, as the flu vaccine prevented 105,000 hospitalizations and 3,500 deaths in the United States in the 2023-2024 season.

In our organizations, pharmacists provide team-based clinical services in both inpatient and outpatient settings. Clinical pharmacists collaborate with our physicians, nurses, and other healthcare professionals to provide safe and effective medication use and improve patient health outcomes while <u>reducing</u> <u>workload burdens</u> on other clinical staff. They educate patients and caregivers about their medications, monitor drug therapy, and coordinate communication between patients, insurers, and interdisciplinary specialty providers. Pharmacists' management of medication therapy has been shown to improve transitions of care and <u>reduce hospital readmissions</u>.

Congress must support ECAPS to protect our nation's rural and senior communities from the threat of infectious diseases. ECAPS would provide payment for essential pharmacist services under Medicare Part B, enabling pharmacists to continue to safeguard patients from the threat of influenza, RSV, and other common infectious diseases. Operating within state scope-of-practice laws that already allow for the delivery of select services by pharmacists, this bipartisan legislation will ensure seniors maintain access to essential testing, treatment, and vaccination services for select diseases.

We urge you to support and advance ECAPS to ensure rural and senior communities have continued access to timely and reliable health care and services provided by pharmacists.

We stand ready to engage with you on this timely and important effort.
